




Building

- 10% more energy efficient than ASHRAE 90.1 standard
- High Efficiency Chillers (15% energy reduction)
- Light colored roof to reduce heat gain and improves energy performance
- Energy Efficient LED Lighting
- Energy Star rated equipment
- Water saving toilets, faucets, and fixtures
- All classrooms have daylighting
- Over 75% of ALL spaces have daylighting
- Thermal efficient windows/glazing

- Native/low water plants reduce water consumption
- Low Impact Design (LID) stormwater design




